## WITH OPTIONAL COSMETIC COVERAGE.

Your MINI is brilliance engineered to stir your soul. If your tires or wheels are ever damaged due to road hazards such as metal, nails, glass, debris, or potholes, we offer Tire & Wheel Protection.

Optional Cosmetic Coverage also offers you the additional coverage of cosmetic wheel repair, so your new vehicle can continue to look its best for years to come.

#### TIRE & WHEEL PROTECTION BENEFITS:

- Replacement of a tire if structurally damaged due to a covered road hazard (includes tires with run-flat technology).
   Tires are never plugged or patched.
- Replacement of a wheel if road hazard damage prevents the wheel from sealing to the tire or maintaining the tire manufacturer's air pressure specifications.
- Coverage of approved costs associated with the replacement of the tires and/or wheels, including labor charges, mounting, balancing, valve stems, tire disposal, and taxes.<sup>1</sup>
- Replacement OEM or aftermarket tires and wheels during your Agreement term, if they meet the manufacturer's size specifications.
- Reimbursement of towing expenses up to \$100 per occurrence in the event of covered road hazard damage.
- No deductible if purchased as part of a protection package.
  If purchased as an individual product, a \$50 deductible will be applied per replacement claim, regardless of how many tires and/or wheels are being replaced at that time.

#### OPTIONAL COSMETIC COVERAGE ADDS:

- Cosmetic wheel repair for damage such as nicks and scrapes.
- Cosmetic wheel repair is limited to sanding, painting, or refinishing the wheel without the need to apply additional material or bend/straighten the wheel.
- Cosmetic wheel repair is limited to a total of eight (8) individual wheel repairs during the Agreement term if purchased as part of a protection package. If purchased as an individual product, cosmetic wheel repair is limited to a total of four (4) individual wheel repairs.
- No deductible for cosmetic repairs.

#### COVERAGE EXCLUSIONS MAY APPLY:3

- Damage to tires with less than 3/32" tread depth at the lowest point on the tire at the time damage occurs.
- Cosmetic damage to tires.
- Cosmetic damage to chrome wheels and/or chrome-clad wheels, even if Optional Cosmetic Coverage is purchased.
- Damage caused by vandalism.
- Repairs/replacements made without prior authorization.
- Damage caused by road conditions (such as uneven lanes or metal plates) found in construction zones or construction sites.
- Failures due to normal wear and tear, improper wear, or dry rot.

Tire & Wheel Protection with Optional Cosmetic Coverage is available only at the time of vehicle purchase as part of a Multi-Coverage Protection option or as a stand-alone product.

Your MINI's handcrafted design may be compromised at any time. Dent Protection offers optional protection that helps keep your vehicle looking its best for years to come. Our paintless dent removal process permanently repairs door dings and minor dents without harming your vehicle's paint job or requiring new coats of paint.

#### DENT PROTECTION BENEFITS:

- Permanent removal of door dings and minor dents without harming the vehicle's factory finish.
- Repair of dents and dings, no larger than four (4) inches in diameter, that are within an accessible area on a body panel of your vehicle.
- Hail damage covered up to the lesser of your comprehensive damage deductible, if a claim was filed with the primary insurer, or \$1,000 per incident.<sup>1</sup>
- Repairs can be performed conveniently at your home, office, or a MINI Dealer.



#### ADDITIONAL BENEFITS:

- No mileage limitations, no limit to the number of occurrences, and no deductible.
- Transferable coverage may add to your MINI's resale value if you sell your vehicle to a private party.<sup>2</sup>

- Unlimited repairs of the front windshield during the Agreement term.<sup>2</sup>
- Repairs can be performed conveniently at your home, office, or a MINI Dealer.


- No mileage limitations, no limit to the number of occurrences, and no deductible.

- Stress cracks or cracks larger than six (6) inches.
- Repairs that will result in an obstruction of the driver's line of sight.
- Damage caused by hail, vandalism, or neglect.

#### REMEDY A LOST KEY WITH EASE.

Your MINI key is highly sophisticated and contains advanced technology that makes it costly to repair. Key Protection provides coverage if your keys are ever lost, damaged, or locked inside your vehicle. It helps eliminate the hassles of an already stressful situation.

#### KEY PROTECTION BENEFITS:

- Replacement of the covered vehicle key/remote if lost or damaged, up to \$800 per occurrence.
- Lock-out assistance to unlock the covered vehicle if your vehicle keys are lost, damaged, or locked inside your car, up to \$100 per occurrence.
- Towing assistance to the nearest registered MINI Dealer or other facility of your choice, up to \$100 per occurrence.
- Taxi/rental vehicle/public transportation reimbursement, up to \$75 per occurrence.



#### ADDITIONAL BENEFITS:1

- Home Lock-Out Assistance benefit includes:
  - Locksmith services up to \$100 per occurrence.
  - Coverage for up to three (3) replacement house keys during Agreement term, up to \$75 per replacement house key.
- Replacement benefit for additional non-programmable keys on the same key ring as the vehicle key/transponder, such as home or apartment keys, office keys, motorcycle, or RV travel trailer keys, up to \$250 per replacement.
