- ⦿ Permanent removal of door dings and minor dents without harming the vehicle's factory finish.
- ⦿ Repair of dents and dings, no larger than four (4) inches in diameter, that are within an accessible area on a body panel of your vehicle.
- ⦿ Repairs can be performed conveniently at your home, office, or a MINI Dealer.
- ⦿ No mileage limitations, no limit to the number of occurrences, and no deductible.



COVERAGE EXCLUSIONS MAY APPLY:¹

- ⦿ Dents or dings that are larger than four (4) inches in diameter.
- ⦿ Dents or dings that cannot be repaired by the paintless dent repair process.
- ⦿ Damage caused by vandalism.
- ⦿ Damaged caused by hail.
- ⦿ Repairs that will affect or damage the vehicle's paint or finish.

Dent Protection is available only at the time of vehicle purchase as part of a Multi-Coverage Protection option or as a stand-alone product.
